**Payments and Electronic Remittances:**

To ensure proper credit to your account, all mailed payments and especially electronic remittances must reference your invoice number. Failure to do so may result in processing delays resulting in unpaid invoices and your account being placed on hold for past due invoices.

**Returns, Sales Terms & Conditions**

1. If you wish to return a product, a Return Material Authorization (RMA) number must be obtained by speaking with our Customer Service department at **888 577-PEEL (7335)**.
2. The RMA number must be clearly written on the outside of the returned package. Failure to write the RMA number on the outside of the package shall delay the disbursement of the refund/credit.
3. All returned products must be returned in original packaging or otherwise equivalently packaged as to prevent shipping damage.
4. Credit Issuance:
  - a. A full credit, minus a 15% restocking fee, shall be issued for:
    - Products returned within 30 days of delivery, in original unopened, sealed packaging.
  - b. No credit shall be issued for:
    - Products returned more than 30 days after the RMA has been issued.
    - Disposable items returned opened, used, damaged or unsealed.
    - Products returned without prior authorization and issuance of an RMA number.
  - c. Capital Equipment (in addition to items listed above):
    - Consideration shall be given for reasonable wear and tear. The cost of necessary repairs shall be deducted from the credit amount.
    - Credit will be reduced by the retail price of any disposables or accessories not returned with the system unopened and re-stockable.
    - In the event of a unit return, Customer assumes full responsibility for the proper packaging and shipping of the unit using the originally provided packaging.
    - If the provided packaging has been damaged and the use of it would jeopardize the unit, the customer must purchase replacement packaging from Genesis Biosystems, Inc.
    - The Customer is responsible for all shipping charges and is required to insure the shipment for the full amount of the purchase.
5. May take up to 30 days for processing after date of receipt.
